**June 7, 2022**

Meeting called to order by Clayton Stansell, president. Board members present were Clayton, Keith Wilson, Deanne Wolf, James Valverde and Deb Denk. **Committee reports:**

**Hooley Report, Bob Henning.** Gas is up to \$6.49. Went up 37 cents today.

**EAA, Rose Longmire.** Cornball game has been bought as kids liked it a lot at the fly-in. Next fly-in June 25. Thinking of using East-West runway for parking. Last Young Eagles fly-in was very successful. Lots of good, competent and willing volunteers. Question, do we have insurance for these events that covers our Air Park? Need to have assurance we do, especially if we have a fly-in. Rose asked the Air Park to consider financing porta-potties. Volunteers from previous fly-ins have volunteered for this next fly-in. Committee would like to have fundraiser during the event. Actually, the way to handle insurance for our events is to have them dated and submitted to the insurance company at the beginning of the year, when possible, but notify insurance company immediately of any activity that needs to be covered.

**Airport, Kurt Winker.** Things quiet. AWOS fixed. Called PNM every day and actually got hold of people, but not one called back. We paid \$38,000 several years ago and they have not done the work. Discussion on their refusal to get this done. We paid them and they have not delivered, and they are liable. Further comment on this should follow in the next month.

**Grounds report by David Hamann.** Things good. Mowing will start soon.

**Architecture, Rick Chavez.** Not here when called. Came in later to the meeting.

**Roads, Kurt.** Waiting to hear from George who will consult us on what needs to be completed.

**Blue hangar, Deanne Wolf.** Lien has been filed and letters addressing problems and enclosing copy of the liens have been mailed to the owners. Registered, return receipt requested. One returned so far. They have thirty days to reply.

**Valencia County, Nancy Gonzalez,** was mentioned in News Bulletin article about problem properties. She is interested in what is happening with the blue hangars as one of the owners has acquired the three acres south of the Air Park and is talking about development of the land.
